

Asia Security Initiative Blogger Terms of Use

The aim of the John D. and Catherine T. MacArthur Foundation (“MacArthur”) Asia Security Initiative site at and under the subdomain <http://asiasecurity.macfound.org/> ("Site") is to advance the field of International Peace and Security by enhancing the knowledge and understanding of Asian security issues. MacArthur’s goal is to ensure a friendly and collaborative space, allowing participants to publish content relevant to Asian security. To protect the respective rights and responsibilities of participants and host of the Site, MacArthur offers these website services (the "Services") to you subject to the terms and conditions of use ("Terms") contained herein. By accessing, creating or contributing to the Site and in consideration for the Services MacArthur provides to you, you agree to abide by these Terms. Please read them carefully before posting to or creating any content on the Site.

1. Disclaimer

Unless explicitly designated otherwise, you acknowledge that the content you create on or contribute to the Site, including blog entries, express your research and opinions, and do not necessarily reflect the views of MacArthur. You agree that as a participant on the Site, you are legally independent of MacArthur and are not an employee, partner or co-host of MacArthur. You acknowledge that, except as provided herein, MacArthur does not edit your posts or other content. You as a participant on the Site are solely responsible for the information, analysis and/or recommendations contained in your submitted content. You agree that you must evaluate and bear all risks associated with creating or contributing content for the Site.

2. Site Moderation Policy

MacArthur is hosting these Services to help advance the field of International Peace and Security by enhancing the knowledge and understanding of Asian security issues. MacArthur intends for posts, comments and content in the Site to be insightful, challenging and potentially provocative - and also to meet basic standards of respect and accuracy in tone and content. MacArthur maintains the right to remove or not to post content at our discretion if said content does not advance the purpose of the Site.

The Site is moderated to maintain the respect required for the ongoing discussion to remain productive. Voicing differences of opinion and providing countervailing information or analysis is encouraged - however, hate speech will not be tolerated. You acknowledge that any content you create for or contribute to the Site, including any content to which you link to from the Site, will not include the following:

1. advertisement for products, services or websites
2. racial, gender-based or sexualized slurs or attacks, threats of violence, or aggressive harassment or abuse of other participants on the Site;

3. illegal, obscene or defamatory language;
4. infringement upon intellectual property rights or privacy rights;
5. propaganda or any attempts to influence any legislation (within the meaning of Section 4945(d)(1) of the United States Internal Revenue Code) other than through making available the results of non-partisan, analysis, study or research;
6. attempts to influence the outcome of any specific public election or to carry on, directly or indirectly, any voter registration drive (within the meaning of Section 4945(d)(2) of the United States Internal Revenue Code); or
7. any representation that your content is endorsed by MacArthur.

3. Rights in the Content You Submit

Unless you specify otherwise, any and all works of authorship copyrightable by you and posted by you to the Site (“Content”) are submitted under the terms of a [Creative Commons Attribution-NonCommercial 2.5 License](#). Under this license, you permit anyone to copy, distribute, display and perform your Content, royalty-free, on the condition that they credit your authorship each time they do so. You also permit others to distribute derivative works of your Content, but only if they do so under the same license that governs your original Content. Amongst other things, this license permits RSS aggregators to copy, distribute, display and perform any Content on the Site.



Option for More Restrictive License Terms

If you prefer to offer your Content on more restrictive terms, you may do so as follows: For Content you submit, include in the title a full copyright notice, i.e., your name, the word "copyright" or symbol "©" and the year of first publication. Attribution

When publicly displaying, publicly performing, reproducing or distributing copies of your Content, or Content as incorporated into a collective work, MacArthur will make best efforts to credit your authorship. You grant MacArthur permission to use your name for such attribution purposes. You, likewise, agree to represent yourself accurately. You acknowledge that misrepresentation may lead us, in our sole discretion, to cancel your use of the Services and delete any of your Content.

4. Conduct

Posting

You may not use the MacArthur name to endorse or promote any product, opinion, cause or political candidate. Representation of your personal opinions as institutionally endorsed by MacArthur or any of its grantees is strictly prohibited.

By posting any content, you warrant and represent that you either own or otherwise control all of the rights to that content, including, without limitation, all the rights necessary for you to provide, post, upload, input or submit the content, or that your use of the content is a protected fair use. You agree that you will not knowingly and with intent to defraud provide material and misleading false information. You represent and warrant also that the content you supply does not violate these Terms, and that you will indemnify and hold MacArthur harmless for any and all claims resulting from content you supply.

You acknowledge that MacArthur shall have the right to remove or refuse to post in its sole discretion any content that it considers in violation of these Terms.

Accessing

You understand that all content posted to the Site is the sole responsibility of the individual who originally posted the content. You understand, also, that all opinions expressed by users of this site are expressed strictly in their individual capacities, and not as representatives of MacArthur.
